MINUTES TUESDAY MORNING

June 22, 1982

- 2-1 The Assembly Called to Order
 General Assembly of the Evangelical Presbyterian Church
 began with the hymn "To God Be the Glory" and was opened
 with prayer by Moderator Calvin Gray at 9:30 A.M.
- Business Session Report on Enrollment and Determination of Quorum
 Stated Clerk Ed Davis reported sixty-three (63) Ruling Elders from thirty churches present, and forty-two (42) Teaching Elders, indicating a quorum was clearly established.
- 2-3 Presentation of Docket
 The Stated Clerk presented the "Proposed Docket" given each
 Commissioner with the following amendment: "that the
 Thursday, June 24, worship service will begin at 8:30 A.M.,
 not 9:00 A.M."

ON MOTION the Docket was adopted as amended.

2-4 Minutes of the 1st General Assembly
The Stated Clerk presented the written Minutes previously
distributed to each Commissioner.

ON MOTION the Minutes as written were approved.

2-5 Election of Recording Clerk
TE Dean Wolf, on behalf of the Steering Committee,
nominated RE Jeanne White, Stated Clerk of the Presbytery
of the West, to be Assembly Recording Clerk.

ON MOTION a unanimous ballot was cast.

2-7 Visitors and Observers

The Moderator welcomed Brick Bradford of the Presbyterian Charismatic Communion. Rev. Bradford in turn presented his wife.

.2-8 Election of Moderator

The Stated Clerk introduced TE Dean Wolf, who on behalf of the Steering Committee (Nominating Committee), placed the name of RE Irvin Rinehart (Faith Presbyterian, Cherry Creek Church, Denver, CO) into nomination for the office of Moderator, citing his background, credentials, service, and personal commitment to the Lord Jesus Christ, This nomination was seconded from the floor by RE Robert Bole. There being no further nominations from the floor, the Clerk was instructed to cast a unanimous ballot for Mr. Rinehart, following an encouragement from Moderator Gray as to the always present need for total openness and honesty in the procedures.

2-9 Passing of the Gavel

Upon acceptance of the gavel, symbolic of the Moderator's role, Moderator Rinehart asked Past-Moderator Gray to offer a prayer for the year to come and for the guidance of the Holy Spirit in the work of the Assembly and the Evangelical Presbyterian Church. Moderator Rinehart then addressed the Assembly urging them to be governed by the will of God, the fellowship of the saints, and upholding in prayer the future of the denomination.

2-10 Welcome of the Host Church

Dr. Dean Wolf extended greetings to the Commissioners on behalf of Faith Presbyterian Church and introduced the Local Arrangements Committee. He presented Wes Roberts of Faith Church as the committee chairman.

2-II Report of the Local Arrangements Committee
Wes Roberts, Chairman, introduced Donna McCullough, Sue
Shirley, Jim Hill, Norm Huebl, and Margie Ammons of the host
church and thanked them for their planning and support in
preparations for the 2nd General Assembly.

Retiring Moderator Gray stated that his report (Appendix B) was printed in the Commissioner's Handbook and noted that he would be making a "strong suggestion" to the Assembly at a later time in the proceedings. It was moved by the Stated Clerk and seconded from the floor to refer paragraph #7 to the Assembly Committee on Church Development. This paragraph expresses a challenge by Past Moderator Gray to raise one million dollars in the next 18 months for the purpose of church development. Paragraph #7 reads as follows:

"If we are to meet the challenge of these new congregations, we must encourage them through prayer, give direction through counsel, and help with financing. It costs money to build churches. Those of us who are secure in our buildings need to expand, and in some cases, change our thinking about missions. From our churches plus individuals, I suggest we initiate a campaign to raise at least one million dollars in the next eighteen months to be poured into church development, so by 1984, we can begin to lend a significant amount each year to needy churches. Much more could be done, but this would be a significant start."

ON MOTION the above paragraph was referred to the Assembly Committee on Church Development.

2-13 Amending the Rules for Assembly
RE Donald Harms, Ward Presbyterian Church, speaking for
the Steering Committee, recommended the amending of
Article 3-2 and the deletion of Article 3-3 of the Rules.

ON MOTION by Larry Schmoekel from the floor, the words to be substituted in 3-2 shall be changed to delete the words "Vice-Moderator" and substitute in their place "most immediate Past-Moderator present, or in the absence of any, the Stated Clerk."

- 2-14 Recess
 The Assembly recessed for coffee at 1-:45 A.M.
- Assembly Reconvened 2-15 The Assembly reconvened at 11:20 A.M. The Moderator gave the Call to Worship and the opening prayer. The hymn of praise "Praise to the Lord" was sung, followed by the Apostle's Creed and a prayer hymn, "The Savior is Waiting." Dr. James Van Dyke, First Presbyterian Church, Rome, GA followed with a prayer. Sue Rinehart Crisco, after a short testimony, sang "Changing Water into Wine." Edward Davis, Stated Clerk, Livonia, MI, gave the Scripture reading, Luke 5:27-39. Rev. Calvin Gray, Past Moderator preached the sermon, "The New in the New." The theme of his sermon was flexibility in methodology and flexibility in mission philosophy. The hymn, "Beneath the Cross of Jesus" was sung prior to the celebration of Holy Communion, served by Rev. Gray and Rev. Davis. The service was closed with the singing of "The Lord's Prayer."

The chairman recognized RE Vern Porter and his wife Marjorie for their work in putting this book together. He also presented a World Outreach Council Proposal to be referred to the Committee on World Mission.

ON MOTION by the Stated Clerk, proposal was received and referred.

The Assembly adjourned at 2:50 P.M. to reconvene in public worship at 7:00 P.M.

MINUTES TUESDAY EVENING

June 22, 1982 SECOND SESSION

2-22 Evening Worship

At 7:00 P.M., the Assembly reconvened for a worship service with TE Dean Wolf, Senior Pastor of the host church, Faith Presbyterian, Aurora, CO, presiding. The service began with

several hymns. Dr. Wolf gave the opening prayer, followed by special music from members of the host church choir.

MINUTES WEDNESDAY EVENING

June 23, 1982 FIFTH SESSION

2-35 Assembly Reconvened
The Assembly reconvened at 7:00 P.M. with the call to
worship by the Moderator. The hymn, "The Church's One
Foundation," was sung and the invocation given by the
Moderator. The chancel choir of Faith Church (Aurora)
sang the anthem, "The Lord is My Shepherd." Portions of
Scripture from I Peter 2 and II Peter 1 were read by TE
Dean Wolf, after which he offered the prayer.

A service of ordination followed for the following candidates with TE James Garner and TE Bartlett Hess presiding: Don Green, Glenn Hickman, Fred Lian, Richard Mallard and Wayne Peterson. Candidates Paul Brown and Robert Stauffer elected to be ordained by their respective presbyteries. TE James Garner and TE Bartlett Hess also presided over service of licensure for John Cogley and James Gearing.

ON MOTION by RE Richard Oestreicher of Ward Presbyterian, the World Mission Committee recommended to the Assembly that TE Douglas Thompson, Ward Presbyterian, be permitted to fraternally serve the Free Evangelical Church of France for a term of five years.

2-41 Report of World Mission Committee
RE Richard Oestreicher, Chairman, presented the report
(Appendix F) and moved that Recommendations #1 and
#2 relating to Rev. Douglas Thompson's call to ministry
in France.

ON MOTION the above recommendations were sustained.

The World Missions Committee recommended that the EPC constitute a World Outreach Council. TE Andrew Jumper made an amendment to accept the report in toto in principal and refer it to a committee of three persons to develop a Manual of Operations. (Refer to report of Church Development Committee.) Debate against the motion to refer followed.

ON MOTION the amendment was sustained.

ON MOTION the third recommendation of the report was adopted.

ON MOTION the report in full was received.

The Stated Clerk charged the churches in the General Assembly to seriously consider Recommendations #1 and #2 of the World Mission Committee report for interpretation and support in local mission programs.

2-42 Ministerial Vocation Committee

TE James Garner, Chairman, presented the report on "Uniform Procedures on Candidacy, Licensing, and Ordination" (Recommendations#1-6).

ON MOTION by TE Donald Hyer, Recommendation #2 was amended by adding "(f) Other evidence-assurance those spiritual gifts needed for effective ministry are present and being developed."

ON MOTION by TE Donald Hyer a recommendation was received to amend the Book of Government, §13-2, to reflect the above concern for spiritual giftedness at the time of examination for ordinations and the time of reception as a candidate, §12-1(B). This motion was referred to the Permanent Judicial Commission for 1983 action.

A motion by TE Steven Barrett to amend the report by deleting Recommendation #3 was defeated.

A motion presented by TE David Massimi to amend Recommendation #3 by adding a sub-section (c), stating that the time limit for Recommendation #3 be three years, was defeated.

ON MOTION by TE Philip Muir the Orders of the Day were called.

2-43 Recess The Assembly was recessed for ten minutes.

2-44 Assembly Reconvened

ON MOTION by TE James Garner and on recommendation from the Ministerial Vocation Committee, the report was amended by deleting the following from #4-B of the report: "Such licensure shall be for a stated period of time and a specific place" and to change the word "may" in the first sentence to "shall."

ON MOTION the report as amended on "Uniform Procedures on Candidacy, Licensing and Ordination" was approved.

ON MOTION Recommendations #9 and #10 were adopted.

ON MOTION by TE Lawrence Schmoekel Recommendation #8 was amended by adding a comma after "two weeks," and by adding the words "cumulative up to six weeks."

RE Vern Porter moved to amend Recommendation #7 to four weeks instead of one month. Motion defeated.

ON MOTION Recommendations #7 and #8 were approved as amended.

ON MOTION the amended report as a whole was received.

2-45 Christian Education and Publication Committee
TE James Dixon, Chairman, presented the committee
report (Appendix H) and asked the Assembly to add the
name of RE Keith Gilchrist to the Committee.

ON MOTION the report on Christian Education was received and its content referred as an advisory from the Assembly to the Permanent Committee on Christian Education and Publications.

2-46 Assembly Committee on Administration RE Donald Harms, Chairman, requested the privilege of introducing the report (Appendix I) with prayer.

ON MOTION Recommendation #1 of the report was received.

ON MOTION Recommendation #2 of the report was received.

TE George Scotchmer asked the Assembly to read the "Essentials of Our Faith" in unison. He noted to the Assembly that additions to this document were under—lined in the Commissioner's Handbook.

ON MOTION by TE Wallace Hostetter on point #5, the words "and where Scriptural discipline is practiced" were added after "integrity."

ON MOTION by TE Malcolm Brown also on point #5, the words "and where loving fellowship is maintained" were added after "practiced."

A motion was made by RE John Prentis to use in paragraph #1 the word "record" instead of witness. Motion defeated.

An additional motion was made by RE John Prentis to use in paragraph #1 the words "in all matters of faith and practice" instead of "in all matters on which it speaks." Motion defeated.

APPENDIX A

RULES FOR ASSEMBLY

As Amended by 2nd General Assembly Evangelical Presbyterian Church

I. Date and Place of Meeting

- 1-I The General Assembly of the Evangelical Presbyterian Church shall meet annually on the date and at the place fixed by the preceding General Assembly, between May I and June 30.
- 1-2 The place of meeting shall be rotated among the various areas of the church as much as is practical. Any presbytery or church outside of presbytery that desires to entertain the General Assembly shall forward an invitation to the Stated Clerk no later than a month before the preceding Assembly.

II. Organization of a General Assembly's Meeting

- 2-I The General Assembly shall be called to order at the designated time by the Moderator, and shall begin with a worship service.
- 2-2 The Stated Clerk shall present a report on the enrollment and declare if a quorum is present.

 If such is present, the Assembly shall be declared to be properly constituted.
- 2-3 The first order of business shall be the election of a Moderator. There shall be only one nominating speech not to exceed five minutes for each nominee. No seconding speeches shall be permitted.

- 2-4 If more than one Commissioner is nominated, election shall be by ballot, on ballots provided by the Stated Clerk. Tellers appointed by the Stated Clerk shall gather, count and report the ballot tabulation to the Stated Clerk. Election shall be by majority. Should no majority exist among a plurality of nominees, a second ballot shall be called for the two highest nominees. The Moderator shall declare the election.
- 2-5 As soon as the Moderator shall have been declared elected, he shall assume his duties as Moderator.

III. The Moderator

- 3-I The Moderator shall preside at all sessions of the Assembly except for those times when the Moderator may temporarily invite another Commissioner to act as the presiding officer.
- 3-2 The Moderator shall call the succeeding Assembly to order and preside until a successor has been elected. A sermon from the retiring Moderator is appropriate. If the Moderator is unable to act, the most immediate past moderator present, or in the absence of any, the Stated Clerk shall call the Assembly to order and preside over its session until a Moderator has been elected.

IV. The Stated Clerk

4-I The Stated Clerk shall be elected on the last day of the Assembly. A new Stated Clerk shall assume office at the end of the Assembly, or at such time thereafter as designated by the General Assembly.

- 4-2 The Stated Clerk shall perform the duties assigned by the Book of Government and by the Standing Rules of the Assembly, and such other duties as are assigned by action of the Assembly.
- 4-3 The Stated Clerk shall assemble the items of business to come before the Assembly and prepare a daily docket for the receiving of committee reports and consideration of all appropriate business to come before the Assembly.
- 4-4 The Stated Clerk shall keep the Minutes of the General Assembly. He shall publish them annually with statistical reports of the Church and reports of the committees of the Assembly.
- 4-5 The Stated Clerk shall have the privilege of the floor in all matters pertaining to his office and at such times when the Moderator, chairperson of Assembly committees, or any commissioner request clarification of Assembly business.
- 4-6 The Stated Clerk shall be the parliamentarian of the General Assembly.

V. The Assembly Arrangements

5-I The Moderator of the last General Assembly and the Stated Clerk shall plan the periods of worship at the meeting of the Assembly, including the celebration of the Lord's Supper and public services. A brief worship service shall be included at the beginning of each day's session.

- 5-2 The Lord's Supper shall be celebrated by the General Assembly on the first day of its meeting. The retiring Moderator shall preside on this occasion and shall preach a sermon or deliver an appropriate address. The newly elected Moderator shall assist in this service.
- 5-3 The first order of the day, except the opening day, at the beginning of the business session shall be the presentation of a docket listing the business which is to be considered that day. Revision of the docket may be necessary during the day.
- 5-4 The Stated Clerk shall oversee all arrangements for the meeting and housing of the General Assembly in conjunction with the host presbytery and/or host church.

VI. Communications and Overtures

- 6-I A communication to the General Assembly is formal correspondence received by the Stated Clerk from other churches, interchurch agencies, and from other organized bodies outside the church proper having business with the Assembly.
- 6-2 The Stated Clerk shall recommend to the Assembly reference for all communications.
- 6-3 An overture ordinarily is the request of a presbytery for action by the General Assembly upon a specific matter.

6-4 All overtures shall be delivered to the Stated Clerk at least thirty (30) days prior to the opening of General Assembly. No overtures received by the Stated Clerk less than one month prior to the opening of the Assembly shall be considered by its Assembly convening in that year. Overtures from the floor of General Assembly shall be considered only if received by a 2/3 vote of assembled commissioners.

VII. Reports to the General Assembly

7-I The Moderator, Stated Clerk, standing committees and special committees shall make annual reports. Such reports shall be transmitted to the Stated Clerk by at least thirty (30) days prior to the opening of the General Assembly. These reports shall be referred to the Assembly by the Clerk.

VIII. Assembly Committees

- 8-I All business shall ordinarily come to the floor of the Assembly for final action through Assembly Committees, except reports of Ad Interim Committees, which shall report directly to the Assembly. The following committees shall handle the matters indicated:
 - 1. Administration touching administrative matters
 - 2. World Mission touching world outreach
 - Church Development touching home missions and evangelism
 - Christian Education and Publications touching Christian education and publications

- Ministerial Vocation touching preparation and care of ministers
- Presbytery Review touching presbytery ministry and action
- 7. Fraternal Relations touching other denominations and agencies.
- 8-2 The Moderator will appoint chairpersons of each Assembly Committee. Representation will be presbyterial with membership-at-large being no greater than 10%. The Assembly Nominating Committee will elect committee personnel from commissioner registrations prior to Assembly convening. Ratio should be as close to 2: I (RE: TE) as possible.
- 8-3 The Committees may be scheduled to meet prior to the opening session of the Assembly to handle business referred by the Stated Clerk.
- 8-4 The Assembly Committees shall proceed as follows:
 - 1. At the assigned time, each committee shall assemble in its assigned place, elect a secretary, review material in hand and begin its work.
 - 2. Each committee shall be available to reconvene to consider additional matters referred from the Assembly floor.
 - 3. A quorum is considered to be a simple majority.
- 8-5 The Assembly Committees shall be brief and concise. It shall include the following:
 - A list of all items referred to and considered by the committee;

- 2. A statement of all issues discussed;
- 3. A report of all recommendations contained in reports, communications, and overtures referred. Action taken by the Assembly committees to approve, modify, or not approve those items referred shall be reported back to the Assembly with reasons.
- 8-6 Minutes of the correspondent permanent committee shall be submitted to the Assembly committee for review.
- 8-7 Informational presentation of some special aspects of the work reported by a particular Assembly committee shall be limited to five minutes.
- 8-8 Any recommendation affecting the Budget of the Assembly shall be referred to the Committee on Administration for review before presentation to the Assembly.
- 8-9 The completed report of an Assembly committee shall contain the full text of the report and handled as follows:
 - 1. Typed in double space
 - Proofed and signed by chairperson of committee and thereafter given to Stated Clerk for permanent record.
 - 3. Presented to the Assembly during docketed time by chairperson or designate.
- 8-10 No partial report of an Assembly committee shall be presented without consent of the Assembly.

- 8-II I. Presbytery Minutes shall be examined for conformity to:
 - a. the constitutional standards of the church, as to the substance of the actions recorded;
 - b. appropriate standards as to the use of the English language.
 - 2. Each set of Presbytery Minutes must be read by at least two members of the Committee on Review.
 - 3. The findings of the Committee with respect to the Minutes of each Presbytery shall be reported under the following categories as appropriate;
 - a. Notations: Typographical errors, misspellings, improper punctuation, non-prejudicial statements of facts and other variations in form may be reported here. Also, failure to provide sufficient or proper information or identification, misstatement of facts, etc., may be included here.
 - b. <u>Exceptions</u>: Violations of constitutional standards or actions which in substance appear not to conform to EPc standards should be reported here.
 - 4. The Committee should prepare a report concerning the Minutes of each Presbytery. After action by the Assembly, two copies shall be given the Stated Clerk, one for his permanent file and one to be mailed to the Stated Clerk of Presbytery.

- 5. Notations and exceptions in the Committee's report shall be handled as follows:
 - Notations shall be forwarded to the Stated Clerk of the Presbytery without being read to the Assembly or recorded in its Minutes;
 - Exceptions shall be read before the Assembly, recorded in its Minutes, and disposed of as the Assembly determines.
- 6. The Presbyteries shall take note in their Minutes of exceptions and notations conveyed from the Assembly and advise the next Assembly of the disposition they have made of such.

IX. Permanent Committees

- 9-1 The ministries of the Assembly shall be conducted primarily through Permanent Committees, to wit;
 - I. Committee on Administration (this committee replaces present Steering Committee)
 - a. Chaired by most immediate past moderator;
 - b. Committee membership: Moderator, Stated Clerk, Immediate Past Moderator, six elected members plus chairperson of other permanent committees. The chairpersons from other committees shall be advisory members and have voice but no vote.
 - c. Functions in the following ways:
 - Administrative oversight
 Oversight and coordination of Adminis-

tration Committee with World Outreach, Christian Education, and Ministerial Vocation Committees

- •Response to emergency and disaster situations
- •Serve as Directors of the Corporation.
- 2. Denominational Development
 - •General Assembly Planning
 - •Promotion Public relations
 - Personal Administration staff hiring, staff accountability
 - •Budget development receive projections from all committees and submit to General Assembly a proposed budget
 - •All legal and corporate matters
 •Insurance, pension, retirement
- All other business or ecclesiastical matters not specifically assigned to any other committee.

2. Committee on Christian Education

- To be composed of six members, to elect own chairperson;
- b. Duties:
 - 1. Curriculum development
 - Provide resources for church/Christian day schools - all levels
 - Provide assistance in Sunday School development and operation
 - 4. Publications other than curriculum
 - 5. Camp and conference development
 - 6. Lay leadership development
 - 7. Worship and music resources

3. Permanent Judicial Commission

"The Permanent Judicial Commission: The General Assembly shall establish a PJC. The Commission shall consist of a minimum of nine persons in three classes of three each, and of which at least two-thirds must be Ruling Elders. The Assembly shall determine their eligibility to succession. Efforts shall be made to give fair representation to various presbyteries. During service on this Commission, no member may hold office or employment in the court. Its quorum shall be two-thirds of its membership. It shall elect its own moderator and a clerk from among its members and a careful and accurate record shall be kept of its deliberations and actions, with a permanent record of these minutes filed with the Office of the Stated Clerk of the General Assembly." Duties of the PJC described in Book of Government, §16-27.B.

4. Committee on World Outreach

a. To be comprised of six members on a three-year, three class system, with the EPC Moderator and Stated Clerk to serve ex-of-ficio members. The CWO will elect replacement members from within EPC membership. Members may serve a maximum of two terms and then may not be re-elected without at least one year's break. CWO members are to include two teaching elders and four ruling elders. The CWO to meet at least twice a year

including the General Assembly.

5. Committee on Denominational Development

- a. Membership to be six members, chairperson elected by committee;
- Duties: to give oversight and planning to the domestic ministries in church planting, evangelism, and church development.

6. Committee on Ministerial Vocation

- Memberhsip to be six members, chairperson elected by committee;
- Monitor and aid ministerial relations committees of local presbyteries;
- c. Placement of pastors and helping churches to find pastors;
- d. Provide information on colleges and seminaries;
- e. Examine extraordinary candidates;
- f. Theological testing oversight.

7. Committee on Nominations

- a. Membership to be nine persons, chairperson elected by committee;
- Teaching elders and ruling elders representative of each presbytery; Teaching and ruling elders at large;
- Duties: to serve and nominate persons for all Assembly Committees, both permanent and standing.
- 9-2 The power and authority of the Permanent Commit-

- tees shall be those set forth in these Rules or by
- 9-3 Each committee shall be constituted on a threeyear, three-class structure.
- 9-4 A majority of a Permanent Committee shall constitute a quorum.
- 9-5 The chairman or secretary of each Permanent Committee shall be elected annually at the first meeting of the committee following the General Assembly.

X. New Business

- 10-1 Any matter presented in any form which has not been received by the Stated Clerk prior to the opening of General Assembly shall be treated as new business.
- New business must be presented to the Assembly before the close of the second day of business. The Steering Committee may assist the Clerk in referring all new business coming to the Assembly.

XI. Parliamentary Procedure

- Rules, Revised Robert's Rules of Order shall be the standard in parliamentary procedure.
- In presenting the report of a committee, the Chairperson shall lead the Assembly in a brief prayer before making the report. The entire report shall be read before any comment. The Assembly may

RULES FOR ASSEMBLY (continued)

waive the reading of any particular report by a majority vote of those present. When a majority of a Committee wishes to present a minority report, the member reporting for the minority shall have the privilege of presenting the minority report and moving it as a substitute for the portion of the majority report affected.

- 11-3 Each recommendation in each report must be read, considered, and acted on separately.
 - 1. The Chairman moves the adoption.
 - 2. Motion to adopt is seconded from the floor.
 - 3. The Moderator asks: Is there objection or question?
 - 4. Hearing no objection or question, the Moderator states: It is adopted. (Above procedure known as "Short Form of Voting.")

11-4 Procedure in debating a question:

- The Committee chairperson may answer questions concerning the report addressed through the Moderator.
- 2. The Chairperson shall the opportunity to make the final statement in debate.
- No Commissioner may speak on the same question more than once until all desiring to speak have done so.
- 4. Debate on the main motion shall be limited to ten (10) minutes unless extended. A simple majority may extend debate an additional five (5) minutes.

RULES FOR ASSEMBLY (continued)

- 5. Debate shall be free, open and responsible with equal time being given to proponents in so far as possible.
- II-5 All motions should be presented in writing and read before being voted on.

XII. Amendment or Suspension of Rales

The Rules of the General Assembly may be amended or suspended only by a two-thirds (2/3) vote of the total enrollment of the Commissioners. A motion to amend is debatable. A motion to suspend is not debatable.

APPENDIX B

Report of the Moderator

These past nine months, it has been a delight and privilege for me to serve as your Moderator. I have traveled over 27,000 miles and made some 18 trips. I have spoken at church services, represented the Evangelical Presbyterian Church before search committees, and often met with groups of teaching and ruling elders from several churches. I have noted a great interest in the EPC. When you realize it was little more than a year ago (May, 1981) that our first congregation joined us and when you consider we were but fifteen congregations at our First General Assembly, it is encouraging that, as we meet at this General Assembly some nine months later, we are a denomination of some thirty churches.

We have churches which range in size from 4,000 to less than 50 members. A keen sense of family has been present in all our gatherings. I have been deeply impressed by the concern which our pastors and ruling elders have for each other. May it continue! In these first two years, by design, the Steering Committee has been charged with an important role of leadership. Their spirit of cooperation and enthusiasm to accept and follow through on responsibility has been a source of encouragement. I am especially grateful to our able Vice-Moderator, Irv Rinehart, and to our dedicated and wise Stated Clerk, Rev. L. Edward Davis.

What propective does your Moderator have on our future? While we are still a tiny denomination, I am extremely optimistic about our future.

Up to the present, a large share of our growth has come from churches which have withdrawn from the UPCUSA and PCUS denominations. We expect there will be other which will come to us via this route. However, we must not look to this as an exclusive source of future growth. We need to be a church planting and growing denomination. When a group of believers is discovered who desire to begin a church, we need to give such a nucleus our encouragement and guidance. Also, we must launch out on a planned program of church planting and growth. The General Assembly should address this issue, and set up some means to meet this challenge. This, in my judgment, is a top priority.

Many have already shared ideas on the "How To's" which have merit. We have already seen a pattern where our two largest churches have given birth to new churches. Recognizing our Lord as the sovereign builder, there is no doubt we need to start from our base of strength and develop a strategy. At the same time,

we must be open to what God is doing and will do "beyond our plans."

EPC churches are currently facing tremendous challenges. Over one-third of our congregations have no church buildings they can call their own. For some, their building was the price they paid for their freedom. On this May 2, our first worship building was dedicated, Trinity Presbyterian Church in Plymouth, Michigan - the first of many, to be sure!

If we are to meet the challenge of these new congregations, we must encourage them through prayer, give direction through counsel, and help with financing. It costs money to build churches. Those of us who are secure in our buildings need to expand, and in some cases, change our thinking about missions. From our churches plus individuals, I suggest we initiate a campaign to raise at least one million dollars in the next 18 months to be poured into church development, so by 1984, we can begin to lend a significant amount each year to needy churches. Much more could be done, but this would be a significant start.

I believe God has called the EPC together for such a time as this. We need an evangelical and Reformed witness which is refreshingly balanced and open, willing to be clay in the Master's hands.

There are committees which need to be formed, strategies to be formulated, fields to be discovered, personnel who need to be called and trained. These will all come in due time. Most important of all, we must see the uniqueness of our witness for the Gospel and seize the challenge of introducing men and women to Jesus Christ, allowing God to use us to build His church. The challenge is now. Remember always, "It is not by might nor by power, but by my Spirit, says the Lord."

APPENDIX E

Church Development Committee Report

RECOMMENDATIONS:

- 1. Establishment of Office of General Assembly:
 - A. That the Assembly establish a committee of three persons to develop a manual of operations for the permanent committees of the Assembly, along with the establishment of policies and guidelines for the operation of the office of the General Assembly.
 - B. That the Assembly establish an office of the General Assembly and instruct the Committee on Administration to present to this meeting of the Assembly a proposal of budget and finance for such office, along with the recommendations for the funding of other special or temporary committees and commissions established by this Assembly.
 - C. That the Assembly authorize the employment (calling) of an Administrative Coordinator who shall also serve as Stated Clerk and a Director of Church Development who shall be primarily responsible for church planting and congregational development.
 - D. That the Assembly appoint a staff search committee of three persons to seek employees authorized above.
 - E. That the Assembly instruct the committee established in #1 above to develop the policies and job descriptions for the Administrative Coordinator and Director of Development.
 - F. That the Assembly appoint an Administrative Commission of six persons who shall have the authority of the Assembly to approve the actions authorized above.
 - G. That nominees for committees and commissions outlined above be recommended to the Assembly for approval by the Steering Committee of the General Assembly.
 - H. That the Administration Committee select a permanent place for the office of the General Assembly to be approved by the Administration Commission.

Church Development Committee Report (continued)

- 2. That the Assembly establish a three-year program called "Mission to the Nation." Such mission is to have as its goal church development and new church planting; further, to instruct the permanent Committee on Church Development to propose appropriate projects and to develop a church-wide campaign to raise 2.5 million dollars for this Mission.
 - A. Recognizes that with limited resources we must establish priorities.
 - B. Encourages our congregations to place priority to giving to the Mission to the Nation.
 - C. Encourage local congregations to give an appropriate portion of their benevolence funds to World Mission projects, with the understanding that the EPC commits itself to the development of a church-wide world mission program in the future. (Clerk: Part C lost by motion.)
- 3. Development of New Presbyteries that General Assembly constitutes:
 - A. Presbytery of the East: New York, Pennsylvania, New Jersey, Maryland, Washington, D.C.
 - B. Presbytery of the South: Virginia, West Virginia, North Carolina, South Carolina, Georgia, Florida, Alabama, Tennessee, Kentucky, Mississippi, Louisiana, Arkansas
- 4. Recommendations to permanent Church Development Committee
 - A. That the committee establish a procedure for assisting EPC churches with ministry and financial needs.
 - B. That this committee give top priority to developing a procedure that will assist EPC churches in their fund raising for Mission to the Nation.

APPENDIX F

World Mission Committee Report

Relating to Rev. Doulgas Thompson's Call to Minister in France

RECOMMENDATIONS:

1. The World Mission Committee recommends that the EPC endorse and appoint Rev. Douglas Thompson as an EPC minister, having been given permission by the Presbytery of the Midwest to labor out of bounds to serve under the Free Evangelical Church of France for a period of five years. We recommend that Rev. Douglas Thompson be so commissioned at a service of the General Assembly. It is our understanding that in this relationship, the following responsibilities and accountabilities will exist:

A. EPC to Rev. Thompson -

. Ongoing prayer support and encouragement;

- 2. Supervision of financial arrangements and provision for the Thompsons, including normal minister's benefits. Churches will be encouraged to assist when established needs are greater than available funds. Funds will be accumulated by EPC and remitted periodically to the Free Evangelical Church of France.
- Correspondence and personal contact, fellowship and encouragement;
- Verify that the Thompsons are receiving adequate personal care, spiritual fellowship, training, and supervision.

B. Rev. Thompson to EPC -

- Report on use of expense and other non-personal funds at appropriate intervals.
- Report on ministry and relationships two to four times per year.

C Free Evangelical Church to EPC -

- Disburse funds remitted by EPC to Rev. Thompson.
- An annual report describing progress during the past year and goals for the next year in relation to the Thompson's ministry.
- 2. We further recommend that the EPC encourage its churches to Consider Doug and Linda Thompson for regular missionary support.

World Outreach Committee Report (continued)

World Outreach means proclaiming the Gospel of Jesus Christ, making disciples, and planting churches. World Outreach includes the hidden peoples of the world among whom there is yet no viable church. It also includes elements of our own as well as other cultures.

The World Outreach to which the following recommendations applies are mission endeavors that extend beyond our EPC churches' local evangelism and daughter church development. The scope of the World Outreach Council does not include domestic (USA) EPC church extension.

3. Until such time as the EPC contains 200 member churches, it is recommended that the EPC establish a permanent World Outreach Committee and appoint six members on a three-year, three-class system, with the Moderator and Stated Clerk to serve as ex-officio members. The Committee will elect replacement members from within EPC membership. Members may serve a maximum of two terms and then may not be reelected without at least one year's break. CWO members will include two teaching elders and four ruling elders. The CWO is to meet at least twice a year, including General Assembly.

When the EPC reaches a membership of 200 churches, an enlarged structure is to be presented at the next General Assembly.

4. Duties of Committee:

Interpretation: Ministry goals and operations, missions education, promotion and motivation (data processing and publications), broadly encompassing World Outreach for all EPC churches as well as for individual EPC churches.

Service: Foster ministry careers and short-term service; encourage candidating and internships; develop and promote mission career path materials; appointment of approved candidates; may establish EPC mission projects and fields.

Relationships: Review and establish relations with sister

Relationships: Review and establish relations with sister denomination mission programs and associations (e.g., EFMA and ACMC).

Funds: Disburse available funds for world outreach, validation of mission agencies and projects. Most EPC churches have developed good working relationships with various mission agencies; routing local church funds through an EPC office would only lead to duplication of work. Therefore, churches are encouraged to administer their own financial distribution at this time.

APPENDIX G

Ministerial Vocation Committee Report

"Uniform Procedures on Candidacy, Licensing & Ordination' (As Amended)

RECOMMENDATIONS:

- 1. Candidates for ordination must fulfill all requirements for ordination and until receiving a call, they will be licensed.
- 2. Requirements for ordination shall be:
 - A. Bachelor's degree from an accredited college or university.
 - B. Seminary degree M. Div. or equivalent including Koine Greek and Hebrew
 - C. Care of Presbytery for a minimum of one year
 - Examinations Four written and one oral examination must be sustained
 - E. Valid call
 - F. Other evidence Assurance those spiritual gifts needed for effective ministry are present and being developed.
- 3. All exceptions to fulfilling standards for ordination (extraordinary candidate) will be referred to permanent Assembly Committee on Ministerial Vocation for a recommended course of action, including continuing education and reading requirements. The Presbytery of Jurisdiction shall in conjunction with the Assembly Committee on Ministerial Vocation:
 - Mail necessary documentation (personal history, etc.) to Assembly Committee for their review and counsel and
 - Proceed with process of ordination only after receiving recommendations from Assembly Committee on Ministerial Vocation.
- 4. Licensure shall be granted to eligible candidates according to the following:
 - Persons may be licensed by the Presbytery for specific duties within the church (extra-ordinary candidate) including the possibility of offering the sacraments if situation warrants such.
 - 2. Persons shall be licensed by the Presbytery prior to ordination. All licensures are to be reviewed annually by the appropriate presbytery committee.

- 5. Provision may be made for a session to commission specific ministries of those not expecting to be ordained for the term of their employment, e.g., music, Christian education, etc.
- 6. Persons seeking membership within a presbytery may be received as enrolled members only upon evidence of a call endorsed by that presbytery.
- 7. Terms of call: The amount of annual vacation time: one month
- 8. Terms of call: The amount of time to be given for study leave: two weeks, cumulative up to six weeks.
- This Assembly shall extend a call as Evangelist to Richard Mallard for the purpose of developing a new church in upper New York State.
- 10. This Assembly shall extend a call as Evangelist to Don Green for the purpose of developing a new church in Bristol, Tennessee.

APPENDIX H

Christian Education & Publications Committee Report

The Christian Education and Publications Committee of the General Assembly of the Evangelical Presbyterian Church was called to order with prayer by Chairman TE James Dixon at 3:15 P.M. on Tuesday, June 23, 1982. Members present were RE Elizabeth Holmes, RE Ed McCallum, TE Steve Barrett, TE Phil Muir, RE Margaret Allen, RE John Wainwright, and RE John Prentis. The Chairman appointed Mr. Prentis as secretary.

Chairman Dixon explained to the members of the Committee that their responsibility was to develop an agenda, or set guidelines to be presented to the General Assembly and, upon acceptance by the General Assembly, to serve as general guidelines for the work of the permanent Committee on Christian Education and Publications to be appointed by the Moderator.

After a brief period of discussion, the Chairman directed the attention of the Committee to the following specific areas:

I. Curriculum Development: This subject was discussed at length with several suggestions and recommendations being made. It was concluded that the best service that could be provided in this area at this time would be to survey member churches and correspondent churches as to the curricula they are using or have used in the past; and to review other material available from other evangelical sources. The results of this survey could then be made available to all interested churches.

Specific areas to be reviewed and evaluated are:

a. Sunday School curricula for all age groups;

b. Women's materials;

- c. Communicant and new member materials.
- 2. Lay Ministry Development: The Committee directed its attention to the subject of the development of materials and resources which could assist in the furthering of the ministries of the churches to specific groups of church members such as:
 - a. Newly elected church officers;

b. Those with counseling needs;
 c. Sunday School and other teachers;

d. Leaders for small intra-church groups;

e. Leaders for men's and women's ministries;

f. Family ministry leaders;

g. Special ministries to groups such as children, youth, singles, the elderly, special education individuals and ethnic minority groups.

Christian Education & Publications Report (continued)

It was agreed that materials and programs developed by member churches in these areas should be made available to other churches where practical, and that other materials on the subject should be studied and evaluated.

3. Publications: The Committee discussed the following

specific areas of publications:

a. A "newsletter" to be published on a regular basis. It was the consensus that this should be published at least ten times annually and that it include editorial material as well as straight news. The possibility of arranging for the inclusion of an EPC supplement to the Presbyterian Journal was also raised.

> A booklet describing clearly the theological position and distinctives of the EPC. It was agreed that such a publication was needed and would be

very helpful.

A source book of available materials and resources as developed under points #1 & #2 should be developed.

Worship and Music Resources: It was agreed that after examining existing books of worship developed by other Reformed bodies such a guidebook might be developed for EPC. It was also agreed that a review of hymnals currently in use by member churches would be useful.

The Chairman called for a recess until 10:30 A.M. Wednesday, June 23. Dr. Barrett offered a prayer and the meeting was recessed at 4:30 P.M.

Meeting reconvened Wednesday, June 23. TE Philip Muir suggested the meeting begin with a time of prayer during which each member offered prayers for the leading and direction of Jesus Christ and the Holy Spirit.

Several Committee members suggested Scriptures which should guide the deliberations of the Committee and of the permanent Committee to be appointed. These were 2 Timothy 2:2, Proverbs 9:10, Deuteronomy 6: 1-10, and Colossians 1:28. It was agreed that these should be adopted as the foundation of EPC's Christian Education program.

Continuing Education Programs for Ministers: It was agreed that consideration should be given to the development of programs in this important but often neglected area.

Christian Education & Publications Committee Report (continued)

- 6. Sunday School Development and Operation: It was agreed that information should be developed as the availability of training programs for the administration of church programs as well as for the training of teachers. It was also agreed that information as to the organization and function of Church CE committees should be developed and made available.
- 7. Camps and Conferences: Resources as to existing facilities and programs should be developed, with emphasis on youth experiences and young adult programs. Canoing experiences and mission caravans and conferences on specific areas of ministry should be explored and encouraged.
- 8. Christian Day Schools: Information should be developed as to the experience and organizational structure of existing schools related to member and other churches. The possibility of a pre-general assembly conference on this subject was raised. Other points discussed included the development of "shared time" programs available in some areas, the development of a ministry of assistance for Christian teachers in public and secular schools, and specific preparation of parents to deal with the non-Christian peer group pressures to be found in non-Christian schools.

It was also agreed that books dealing with Christian education should be reviewed and reported on in the denominational newsletter.

In closing, TE Philip Muir stated that his church had developed a program to utilize those elders not currently active on the session as teachers. He pointed out that this was completely in accord with the teachings of Scripture, and that such people are a valuable resource for all churches.

There being no further business the meeting was adjourned with prayer by Mr. Prentis at 11:45 A.M.

APPENDIX I

Committee on Administration Report

RECOMMENDATIONS:

- The Committee recommends that selection of the site of the Third General Assembly, which is to be held June 21-23, 1983, should be made by the Permanent Committee on Administration at its meeting in September, 1982, so that it can consider all invitations which shall have been tendered to that Committee by September 15, 1982, and in making such selection it is recommended that the Committee consider the following criteria:
 - a. Geographical suitability, including convenient accessibility to long distance transportation;
 - b. Capability of accommodating 350 delegates at the sponsoring church;
 - Availability of facilities for seating a minimum of 750 persons for public services either on the church property or public facilities;
 - d. Adequate financial and personnel resources beyond those available from the denomination;
 - e. Adequate support services, including handling of housing, transportation, and food.

The pregoing recommendations shall not be construed to prevent cooperative hosting of the 1983 General Assembly by more than one church in an area.

The Committee further recommends that the Permanent Committee on Administration should establish appropriate guidelines and criteria for use in considering General Assembly sites for years subsequent to 1983.

- 2. The Committee recommends adoption of the language set forth in Appendix VII of the Commissioner's Handbook for the Second General Assembly as amended in Essentials of Our Faith, subject to the following additional amendments:
 - a. The preparatory statement following the first full paragraph shall be amended by deleting the word "as," which appears in the draft set forth in Appendix VII between the words "additional" and "essentials."

Committee on Administration Report (continued)

- b. The third numbered paragraph should be amended by placing a period after the word "service" on the fourth (4th) line and the following sentence should be added: "He instructs and guides us into all truth, and seals us for the day of redemption."
- c. The fifth numbered paragraph should be amended by changing the fourth (4th) word of the second sentence from "its" to "her," a comma should be inserted after the word "imperfect" and the following sentence should be added to said paragraph: "For her perfecting, she awaits the return of her Lord."
- d. The sixth numbered paragraph should be amended by adding the following sentence: "Even so, come, Lord Jesus!" (Rev. 22:20)
- e. The seventh numbered paragraph should be amended by adding the following two (2) sentences: "He calls us to a life of self-denying love and service. For we are his workmanship, created in Christ Jesus for good works, which God prepared beforehand that we should walk in Him." (Eph. 2:10)
- 3. The Committee recommends that proposed new edition edited by Rollinson, McClure, and Kelly of the Westminster Confession of Faith should be referred to the Permanent Judicial Commission for further study.
- 4. The Committee recommends that the fiscal year be changed from an assembly year to a calendar year.
- 5. The Committee recommends adoption of the amended 1981-82 Assembly Budget as set forth in Appendix IX of the Commissioner's Handbook. (9/1/82 12/31/82)
- 6. The Committee recommends adoption of the proposed 1983 Assembly Budget as set forth in the last column of Appendix X of the Commissioner's Handbook, subject, however, to the addition of \$51,300 to provide for the establishment of the position of a permanent Stated Clerk. This additional amount is to include salary and housing, insurance, pension, travel and entertainment. The total amended budget would be 185,100.
- 7. The Committee recommends approval of the Steering Committee's recommendation dated June 22, 1982, as to the description, function, and composition of Permanent Committees of

the General Assembly, subject to the following amendments:

- a. Paragraph I GI should be amended to provide as follows: "I. Membership shall consist of one Teaching Elder and one Ruling Elder elected by each presbytery."
- b. Paragraph 1. G2 should be amended to provide as follows:

 "2. The Chairperson shall be elected by the Committee."
- c. Paragraph 3 should be amended by adding the following language: "All members shall be Teaching Elders or Ruling Elders. In so far as practicable, the ratio of two Ruling Elders to one Teaching Elder shall be maintained."
- 8. The Committee recommends approval of the concept of selfinsurance and the referral of the matter to the Permanent Committee on Administration for decision as to implementation and the Committee further recommends that the Permanent Committee on Administration be authorized to execute a plan in trust as appropriate.

The Committee urges that comments from knowledgable persons as to the insurance program should be forward to the Permanent Committee on Administration.

The Committee also would urge individual churches to assume the deductible portion of the health insurance program and the cost of co-insurance as a part of the minister's compensation package.

Committee on Presbytery Review Report

RECOMMENDATIONS:

- 1. Approval without exception:
 - A. Presbytery of the East, Minutes of February 27, 1982
 - B. Presbytery of the Midwest, Minutes of November 17, 1981
 - C. Presbytery of the West, Minutes of December 8, 1981
- *NOTE: Committee cannot review minutes not already approved by the Presbytery.
- 2. The adoption of the attached "Guidelines For Keeping Presbytery Minutes."

"Guidelines for Keeping Presbytery Minutes"

- A presbytery shall keep its Minutes in a lock type record book with numbered pages. The Minutes shall be typed, printed, mimeographed or otherwise reproduced in neat and legible fashion.
- 2. The opening paragraphs of the Minutes should contain the following information:
 - A. The name of the Presbytery and the kind of meeting stated, called, adjourned-stated or adjourned-called.
 - B. The date, time, and place of meeting.
 - C. The name of the Moderator and if someone other than the Stated Clerk served as Clerk Pro-Tem, his name should be indicated.
 - D. The Minutes of a Presbytery meeting must be approved in the next stated meeting or at the earliest possible succeeding meeting, recording the date of minutes approved.
 - E. The names of those present, indicating whether teaching or ruling elders and the church represented in each case. The Minutes may also include the names of visitors and/or observers.

Committee on Presbytery Review Report (continued)

- F. Excused absences for teaching and ruling elders; unexcused absences should be noted.
- 3. Contents of the Minutes should include:
 - A. The names of persons leading in opening and closing prayer of all sessions.
 - B. In the case of called meetings, the Minutes shall record verbatim the call and purpose of the meeting.
 - C. The actions of the Presbytery, including all motions adopted and business transacted together with such additional information as the Presbytery deems desirable for historical purposes. Normally, each main motion shall be recorded in a separate paragraph. It is desirable for later reading of the Minutes to number each paragraph and provide a brief heading.
- 4. For the sake of any case carried to a higher court the Minutes shall contain a complete record of Presbytery's actions together with all points of order and appeals, whether sustained or lost and the reasons given by the Chair for his ruling.
- 5. Additional Guidelines, adapted from Robert's Rules of Order:
 - A. The names of the mover and the seconder of a motion should not be entered into the Minutes unless ordered by the Presbytery;
 - B. When a count has been ordered, or the vote is by ballot, the number of votes on each side should be entered.
 - C. The proceedings of a committee of the whole should not be entered into the Minutes, but the fact that the assembly went into the committee as a whole, and the committee report should be recorded.
 - D. When a question is considered informally, the same information should be recorded as under the regular rules, since the only informality in the proceedings is in the debate.
 - E. Committee reports that are adopted by the Presbytery may be handled in either of two ways. They may be entered directly into the record at the time when they are presented, and it should be reflected as the report of a committee

Committee on Presbytery Review (continued)

adopted by the Presbytery. The other way by which they may be handled is to give the report as an appendix, to which reference is made by motion in the body of the Minutes. Reports and other matters that are received as information should be retained by the Clerk of the Presbytery, but need not be printed with the Minutes, unless so directed by the Presbytery.

- 6. The Minutes should be signed by the Clerk.
- 7. At least once a year, the Minutes of the Presbytery should include, in addition to the Minutes themselves, the following items:
 - A. A directory of the Presbytery, including a listing of all the regular committees of Presbytery;
 - B. A roll of the Presbytery, including a list of all teaching elders, with their addresses, and of all churches with the names and addresses of the Clerk of Session, and the address of the church.
 - C. A list of all candidates under care of the Presbytery, including the addresses;
 - D. A list of all licentiates of the Presbytery, including the addresses;
 - E. An up-to-date copy of the Standing Rules of the Presbytery.
- 8. The Stated Clerk is responsible for the custody of the Minutes of the Presbytery. He is responsible for the presentation to the General Assembly for approval of all Minutes of the Presbytery which have been approved by the Presbytery not previously approved by the General Assembly.
- 9. A copy of the Guidelines for Keeping Presbytery Minutes should be kept with the Minutes of the Presbytery.

APPENDIX K

Fraternal Relations Committee Report

Items referred to Fraternal Relations were from the Stated Clerk's report, Items F, G, & M.

Item F was considered first. In response to the printed material - Item F and Communications I, II, and III - the Fraternal Relations Committee recommends:

- That the Assembly commends the Steering Committee on their fine work in establishing and maintaining good working relationships with other evangelical and Reformed bodies.
- 2. Pledges with the Evangelical Presbyterian Church to continue pursuing with the highest ethical conduct, fraternal relationship with other evangelical Reformed bodies. (Motion approved by Assembly.)

Reasons for recommendations on Item F:

- We believe that we have a very good beginning due to the excellent work of the Steering Committee. Examples include the first three items of correspondence and the transferring of PCUS pastors and churches.
- The Steering Committee has made this pledge and we feel that the General Assembly also needs to make this pledge.

In reference to Item G, we recommend:

3. that the 2nd General Assembly instruct the Stated Clerk to obtain from the National Association of Evangelicals a statement of faith, their purposes, and an outline of services rendered to members. This information is to be distributed to all Teaching Elders and all Clerks of Session following the acceptance of our membership application by the National Association of Evangelicals.

Reasons: As a denomination we have a posture of openness, and there are many questions that we as a committee could not answer. In our opinion when we are accepted we need to inform our people of the work of the NAE.

Fraternal Relations Committee Report (continued)

In reference to Item M - Correspondence X, XI, we recommend:

- 4. Instruct the Stated Clerk to obtain from the Reformed Ecumenical Synod a statement of faith, their purposes, and an outline of services rendered to members. This information is to be available to the appropriate committee of the Third General Assembly.
- 5. Instruct the Stated Clerk to obtain from the World Alliance of Reformed Churches a statement of Taith, their purposes, and an outline of services rendered to members. This information is to be made available to the appropriate committee of the Third General Assembly. Further, that the Moderator name an observer to attend the General Council of the WARC, meeting in Ottawa, Canada August 17-27. The named observer to make his/her observations in the form of a report to the appropriate committee of the Third General Assembly. (Motion approved by Assembly.)

Reasons for recommendation:

We believe that in order to make valid decisions on possible ecumenical bodies we might join, the information requested is vital. We have committed ourselves to purposing these sort of relations, and again we need to do this in an informed way. The WARC General Council meets only every five years, at most. What is written on paper is helpful, but to actually observe is better.

Additional Recommendations:

6. We recommend to the Second General Assembly that we participate in the next meeting of the North American Presbyterian and Reformed Conference as an observer. The Moderator is to name our observer to the conference being held in Pittsburgh on October 22, 1982. (Motion approved by Assembly.)

Reasons for recommendation:

The members of NAPARC are close to us in theology and spirit and we need to pursue this type of relationship.

Fraternal Relations Committee Report (continued)

7. We recommend that the Administration Committee investigate the desirability and feasibility of holding future General Assemblies concurrently with other Presbyterian denominations.

Reasons for recommendation:

The fellowship of like-minded groups is always pleasing, both to us and to our Lord. This would again be a way to pursue fraternal relations.

8. We recommend that the Second General Assembly, as a matter of procedure, instruct the Stated Clerk that whenever an ecumenical body contacts our denomination concerning our possible affiliation, to write for their statement of faith, their purposes, services to members, and any other relevant material. This material to be made available to the appropriate committee of the next General Assembly.

Reasons for recommendation:

This procedure will enable the process of investigation of ecumenical bodies to be speeded up.

 We recommend that the General Assembly establish a standing Committee on Fraternal Relations.

Reasons for recommendation:

The work of the denomination in examining possible groups with which we might join would be greatly enhanced by a continuing body. The work would be able to be done in a more informed manner, and a much more timely manner. Some of the requests and correspondence with us now are over six months old. We desire to be known as a gracious and prompt fellowship. A standing committee would greatly enhance this.
