Glenn E. Meyers serves as Pastor of Ardara Evangelical Presbyterian Church in Ardara, Pennsylvania. An ordained Ruling Elder serving as a Commissioned Pastor, Glenn has been honored to oversee the revitalization of the vibrant, 120-member congregation in which he grew up.

"From nearly closing to a now-vital gospel ministry, God has done a great work among us," Glenn says. "I am grateful to the pastors, elders, deacons, and church family members who have held the church in trust for future generations while seeking the will of God in the present. We intend to do the same."

A graduate of Norwin Senior High School in in North Huntingdon, Pennsylvania, Glenn went on to study Organizational Behavior at Westminster College in New Wilmington, Pennsylvania. More recently, he attended Reformed Pittsburgh Theological Seminary (RPTS) before being called to his current position. Prior to becoming a Commissioned Pastor, Glenn spent more than 20 years as a Habilitation Therapist and the owner/operator of Habilis Learning Consultants.

"My work with and for adults and children with developmental delays and mental health challenges has been a blessing of profound preparation," he notes.

Raised by his mother and grandmother in a loving home, Glenn says he was "blessed by the many men of the church who cared for, encouraged, and mentored me along the way."

An inseparable ministry team, Glenn and his wife, Heather (the part-time church secretary and full-time mother and grandmother) have six children and seven—and counting—grandchildren. All of their children, who range in age from 13 to 31, have professed faith in Christ and are currently working out their salvation and their individual callings.

Glenn's many diverse opportunities include serving as manager of the Pittsburgh Children's Museum, performing as an actor, and working as a children's librarian. He is an Eagle Scout and has toured with a choir through Europe. He enjoys travel, new food experiences, music, the theater, and art.

"God wastes no experiences," he says. "I am blessed to be part of a church and family in which my very faithful God has begun a good work. With every new opportunity presented by the hand of God, my deepest desire is to honor Him. I am very blessed to be asked to serve Christ's Church to the Glory of my Father."

Dr. Brad Strait is Lead Pastor at Cherry Creek Presbyterian Church in Englewood, Colorado. He has more than 30 years of pastoral experience and also teaches at Denver Theological Seminary in both Leadership and Spiritual Formation. His passion is to exhort people toward a deeper relationship with the living, incarnational Jesus—especially as it applies to prayer, missional living, and world Christianity. His doctoral work was in developing *Spiritual Intimacy with God and Others*.

Brad's energetic faith pushes through the cracks of real life: he was a grief counselor on scene after the Columbine High School shooting in 1999, the Aurora Theater tragedy in 2012, and the 2004 tsunami in south India. He has taught the

Bible around the world and worked with the poor in refugee camps of Central America, South America, Africa, and Asia. He also has served as Chaplain for the Colorado House of Representatives, the Denver Rescue Mission, and several police and fire departments. He has chaired the EPC's Ministerial Vocation Committee and was part of the team that produced the EPC Leadership Training Guide: A Resource for Pastors, Elders, and Churches.
