### Standing Committee Report 43<sup>rd</sup> General Assembly

1. **Recommendation GA43-15:** The MVC Recommends that the 43<sup>rd</sup> General Assembly approve a Moderator-appointed task force to complete a thorough review of our *Book of Discipline* and associated Forms and consult with experts inside and outside of the EPC as needed and present recommendations to the 44<sup>th</sup> General Assembly **be adopted as amended.**
2. **Recommendation GA43-17:** The MVC Recommends that the 43<sup>rd</sup> General Assembly approve the creation of a Moderator-appointed, Ad-interim committee for the purpose of reviewing our ordination standards and process and recommending any potential changes to the 45<sup>th</sup> General Assembly **be approved as submitted.**




