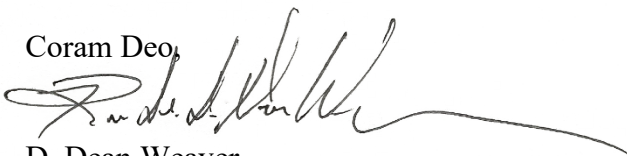
This *Commissioner’s Handbook* includes two sections:

- We have learned much from Engage 2025 as a Global Movement. There are still unreached and unengaged people groups. That continues to be our focus as the fields are white for harvest and the workers are few. I am excited for what God calls us to be as part of His worldwide church.
- Thinking about Effective Biblical Leadership from a Ruling Elder's point of view reminds me of how blessed I was to have mentors take me to GA as a young man. My love for the EPC was nurtured by the relationships formed at GA. Our founders saw engaged RE's as vital to the health of the church. Help lay the foundation for the Next Gen leader by bringing them to the Equipping Sessions and Network Lunches. I am grateful for the Elders who brought me years ago and the welcoming spirit of the EPC family.

My prayer for you this year is that you may feel The Lord's pleasure as you serve His church. May we encourage one another toward growth in our relationship with Jesus and each other as we serve Him together. It has been my honor to serve the Evangelical Presbyterian Church as Moderator. Grace and Peace to you all in the name of our Lord Jesus Christ.

As we gather for this year's General Assembly, let's take a moment to look back on the past year of the Evangelical Presbyterian Church. It's been a year filled with both tough times and incredible achievements. The Christian landscape in America is undergoing significant transitions, with the lines of demarcation, even those that have endured for decades, being redrawn. In this context, the EPC has emerged as a refuge for churches seeking a commitment to Biblical orthodoxy, the Reformed tradition, and an ethos of generous collegiality. We are encouraged to see numerous congregations from both ends of the spectrum seeking to join our ranks during this anxious age.

The responsibilities outlined in Section 10 of the Rules for Assembly guide our work within the National Leadership Team (NLT). Our focus has been on three pivotal areas: Mission Vision and Strategy, Administrative Oversight of General Assembly Committees, and Denominational Development.

Mission Vision and Strategy

This year, we have made substantial strides in Church Health initiatives. As of April, we have 100 transitional pastors actively serving, with a total of 155 trained, including 40 from other denominations who are now available to EPC churches. In addition, 95 Church Health Coaches have been trained, supported by 15 Coordinators across 16 Presbyteries. These efforts are vital as we strive to enhance the vitality of our congregations.

In the realm of Church Planting, Tom Ricks has been instrumental in conducting seminars and briefings for our presbyteries, fostering a culture of growth and outreach. We are particularly excited about the establishment of our Church Planting assessment program, which held its inaugural session this year at Cherry Creek Presbyterian in Denver, CO.

Annie Rose has continued her exceptional work in Effective Biblical Leadership, organizing workshops, retreats, and counseling opportunities that have collectively garnered over 1,282 views in our webinar series. These initiatives are equipping leaders to navigate the complexities of ministry in today's world.

Administrative Oversight of General Assembly Committees

Our administrative oversight has been robust, with 24 teams, including Ad Interim Committees and task forces, supported by the General Assembly office. Comprising approximately 250 members from local churches nationwide, these teams are diligently working to advance the mission of our denomination.

World Outreach remains a cornerstone of our ministry, with the Engage 2025 initiative now involving 15 participating Presbyteries. Additionally, the International Theology Education Network has successfully launched missionary movements in two foreign countries, expanding our global impact.

We are also grateful for our Disaster Relief Committee, which has provided critical aid, assistance, trauma counseling, and family support to EPC churches affected by natural disasters in Florida, North Carolina, and New Mexico. Their dedication to serving those in need exemplifies our commitment to compassion and support.

Denominational Development

In preparation for this year's General Assembly, we have taken the time to reflect on last year's gathering. Engaging with the leadership of presbyteries that had concerns has proven fruitful, and we are optimistic about the positive trajectory of those discussions.

This year has seen significant contributions through the POI initiative, and we extend our heartfelt gratitude to everyone for their faithful giving. Furthermore, we are pleased to announce that the Presbyterian Church of Ireland will ratify our fraternal relationship this year, with TE Andrew Smith representing us. In Egypt, the Synod of the Nile is exploring a relationship with the EPC, potentially unlocking incredible ministry opportunities in previously closed areas. Additionally, Tom Ricks is exploring a church planting partnership with the Presbyterian Church in France, facilitated by our World Outreach partner, Jeff Kim.

Ad-Interim Committees

We are excited to hear reports from our Ad-Interim Committees, all of which have diligently pursued the betterment of our denomination. Notably, the committee reviewing the EPC Standards for Ordination, co-chaired by TE Doug Resler and TE Julie Hawkins, is nearing completion of the first phase of their work and will present their findings at this General Assembly. The Ad-Interim Committee on Same Sex Attraction and Ordination, co-chaired by TE Cameron Schaffer and RE Carol Williams, has made significant progress

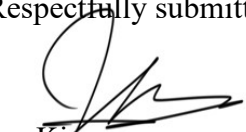

and will also report this GA. The Ad-Interim Committee on revising our Pastoral Letter on Domestic Abuse has disbanded for personal and professional reasons and was unable to complete their work. We look forward to revisiting this vital Pastoral Letter in the future. Finally, the newly formed committee on disability and sacraments, co-chaired by RE Michelle Munger and TE Walter Taylor, is in the early stages of their important work.

While we acknowledge the challenges faced over the past year, we are profoundly grateful for the commitment demonstrated by all within our denomination to pursue peace, unity, and the purity of the church. Together, we are moving forward, encouraged by the accomplishments we have achieved and the opportunities that lie ahead. It has been the honor of a lifetime to serve you as Moderator and this past year as the Chair of the National Leadership Team. Thank you for the privilege and for your continued support and dedication to the mission and vision of the EPC.

Coming out of last year’s Assembly and my re-election, I was deeply strengthened by the many cards, emails, texts, phone calls, and conversations that encouraged me. Over the course of this year, through all the challenges and the tremendous strides forward in our shared mission to live out the Great Commission, that encouragement has only grown. Thank you!

In 2016, at our 36th General Assembly, we changed the name of the Committee on Administration to the National Leadership Team. In 2018, at the 38th General Assembly, we amended *The Rules for Assembly* X. 10-1A to further define and clarify the role of the NLT by adding the responsibilities of mission, vision, and strategy to the National Leadership Team.

In 2019, the Stated Clerk Search Committee created a revised position description for the new Stated Clerk to align with the NLT’s responsibilities. In short, the National Leadership Team supervises the Stated Clerk to carry out the wishes of the General Assembly. My report this year reflects how I was called to serve you as your Stated Clerk.

Growing The Kingdom. Some plant, some water, but God causes the growth. In pursuing our common mission to carry out the Great Commission, we together have identified four Gospel Priorities. Elsewhere in your Commissioner’s Handbook, you will find more detailed accounts of how the Lord is working in building effective Bible leaders throughout the EPC that help lead increasingly healthier congregations that, in turn, multiply by

producing other reproducing churches both domestically and globally. The growth is palpable. This year marks an important milestone for our Gospel Priorities, as our Assistant Stated Clerk, Michael Davis, now oversees all four, with his gifted eyes on our ever increasingly working together (we are Presbyterian after all) as our Chief Collaborative Officer. When Jeff Kim and Johnny Long from EPC World Outreach partner with Tom Ricks and our Church Planting Leadership to lay plans to plant a church together in France, that is working together for the advance of the Great Commission. That is fulfilling our mission. That's just one of many examples. Again, more to be found in reading the many compelling reports at this GA.

The EPC as a whole continues to grow modestly against the larger post-COVID decline evident in the American Church. Our membership largely remained flat, with 125,754 members recorded in our Annual Church Reports (ACR) and 626 congregations. In the last year, we grew by almost 16% in first-time professions of faith and by 20% in Adult Baptisms, both encouraging trends of our living our mission through the primary responsibility of all three of the EPC Church Courts – to do evangelism.

There will be more churches joining the EPC by transfer in the coming year, with an estimated 20 in the pipeline across the country as I write this, and numerous more making inquiries. But our growth as a family of churches, while extending biblical hospitality to those who knock on our doors, must continue to be through the exponential growth of church planting. That is what effective biblical leaders in healthy churches do: they share the gospel, plant churches, and as God sees fit, the Kingdom grows.

Future Focused – In the early days of our founding, you would commonly hear our leaders calling the EPC to be “inwardly strong and outwardly focused.” In short, our Presbyterian and Reformed heritage helps us to remain inwardly strong, and our Evangelical and Missional commitments help us to remain outwardly focused. We must be faithful to both our heritage and our mission.

As we look ahead to the years in front of us with hope, there are great challenges before us. While the challenges our National Leadership Team wrestles with are many, perhaps the most pressing is the concern about a leadership pipeline. As a missional denomination, we have no camps, colleges, seminaries, or campus ministries. For many denominations, these

institutions provide a “feeder system” for rising leadership. In the EPC, we have multiple partners leading these kinds of organizations, but we need to do more in working with them to address a shortage of incoming pastors, church planters, chaplains, and global workers (among others). With potentially as many as 50% of our current pastors retiring in the next 3-5 years (Baby Boomers), we have a good temporary measure started with the training of over 200 Transitional Pastors, but we also need a longer-term solution to address pastoral vacancies, especially for our smaller churches. We earnestly desire to support the great work being done by our smaller churches, since 64% of our congregations comprise less than 100 members. As such, under the direction of the National Leadership Team, we are working to develop multiple strategies to help address the expected increasing pastoral openings in our smaller churches. Stay tuned in the next year for more updates on this vital work.

There are other forward-looking initiatives in the works as well. One exciting new work is the comprehensive task of translating all of our materials and resources into Spanish to better serve many of our existing congregations and our growing number of new Spanish speaking church plants. Another new work is building out new and strategic Fraternal Partnerships that will help us to carry out the Great Commission in some of the hardest and most challenging places we have yet to reach with the Gospel. At this Assembly, we will celebrate a long-awaited partnership with the Presbyterian Church of Ireland, build on a long-standing relationship with St. Andrews Presbytery in Argentina, and welcome new friends from the Synod of the Nile (Egypt) as we explore a fraternal partnership. By God’s grace, we are increasingly a part of a real global gospel movement.

Promoting the EPC Ethos – Coming out of last year’s General Assembly, I was determined to listen widely and carefully, and to work with the National Leadership Team to promote our long-standing ethos of kindness and grace-filled orthodoxy. Some conversations have been with leaders who serve on various GA committees. We have 24 committees or subcommittees of various types currently doing the work of the General Assembly between meetings, which constitute over 250 commissioners from our local congregations (see G. 20-1) both RE’s and TE’s from all around the country and all our 16 Presbyteries. Other conversations have been at Presbytery meetings with individuals and groups, and some with presbytery leadership teams. Each conversation was good, with some more challenging than others, but each filled with grace and listening. The ethos of the EPC was ever present, and I hope and trust that we are leaning into the EPC’s historic DNA of relational accountability and building trust. It’s hard, and ongoing work, but so important if we are to move forward together to carry out the Great Commission.

Under the authority and accountability of the National Leadership Team, the Stated Clerk is also called to assure that the EPC is financially healthy so that it is able to carry out its mission. As you will see in our financial reports this year, God continues to bless our family of churches financially, and we continue to be good stewards of those resources in carrying out our mission. Our annual financial audit (in the finance report) continues to demonstrate sound accounting and financial practices, and our revenue from POI (Percentage of Income) continues to grow faster than the pace of inflation, something PMA

(Per Member Asking) was increasingly unable to do. Whereas in the past, the NLT authorized appropriate designated or unrestricted funds to support and supplement Church Health and Church Planting, those positions are now fully supported in our proposed operational budget. We invested in our Gospel Priorities, and that work is being sustained by God's grace through the generosity of our churches.

Developing Young Leaders – We continue to make significant strides in gathering, encouraging, and equipping the rising generation of leaders in the EPC. Our Next Gen Summit continues to grow, attracting and empowering young leaders (see their report at this Assembly) from across the country, and we continue to see more and more Presbyteries creating their own Next Gen Councils and promoting Next Gen retreats and ministries. One of the great resources and opportunities for us in the next few years will be pairing rising leaders with established leaders. With the EPC now celebrating our 45th GA, it is imperative that we “pass the baton” well, from one generation to the next. This will be a key focus in the next few years.

The Larger Church – It has long been important that the EPC Stated Clerk be connected to the larger Church. I continue the tradition of the Stated Clerk serving on the Board of the National Association of Evangelicals. I have found the annual meeting of denominational leaders to be helpful. I am also privileged to serve on the board of The World Reformed Fellowship. This year EPC TE Cameron Schaffer led an important theological consultation on the Church hosted by EPC Congregation Fourth Presbyterian Church in Bethesda, MD. Senior Pastor Todd Smedley of 4th Pres and Pastor Emeritus Rob Norris are also both on the board of WRF, with Rob serving so well as the National Director.

In December, I attended the State of the Church conference hosted by the Barna Institute and the good people at Gloo. The EPC has contributed to and is benefiting from the depth of data being produced on the State of the Church, specifically in the area of discipleship. This focus on discipleship will be another important point of emphasis as we continue to endeavor to live out our mission of carrying out the Great Commission (make disciples).

Office of the General Assembly Operations – Living in central Florida and working out of the Office of the General Assembly has enabled me to be fully engaged in the day-to-day operations of our Office of the General Assembly. If the EPC's mission is to carry out the Great Commission, then the mission of the OGA is to “serve those who carry out the Great Commission.” To be on mission, the 28 FTE's (full-time equivalent staff) in Orlando, which include our two subsidiary corporations (ESG or World Outreach and BRI – Benefits Resources, Inc.), do not do the work of the General Assembly but serve those who do. While assembling an effective team amid the reality of work post-Covid has been a challenge at times, we now have a fully staffed, highly motivated and dynamic team that exists to serve our 24 committees and subcommittees, our Presbyteries, local congregations as well as our global workers, chaplains, and fraternal partners around the world. It is an honor and privilege to serve alongside them as we serve those who carry out the Great Commission. Whether it is preparing to implement another General Assembly, (an all-year task) or provide funds in disaster relief; answer polity questions, or get the right forms into

the hands of the right people, sending out social media communications or setting up online giving for some of our under-resourced congregations, the OGA exists to serve you!

Each of the areas I have highlighted in this report follows the framework of my position description as approved by the National Leadership Team. While this is far from everything I do as your Stated Clerk, I do hope it will give you a sense of how I have been called to serve you and our beloved EPC family. It is the most challenging, and yet the greatest honor and privilege of my life. The summary of my position description says this: “The EPC Stated Clerk is a servant leader and a visionary. The primary qualification is to be passionate about the Gospel of Christ. The Stated Clerk will be passionate about the EPC and want to see it thrive. The Stated Clerk will model and communicate the ethos and values of the EPC.” It is my deepest prayer, that by the grace of God, I might fulfill this high calling to the best of my ability. Your love and support have meant the world to me and to Beth. Thank you!

Dave grew up in a Christian home with two wonderful parents, and the middle child between two sisters. He became a Christian at 9 years old, when his dad prayed with him on the living room couch. Jack Cathey is a Ruling Elder at Lake Forest Church in Huntersville, NC, where he and his wife Anne have been involved as founding members. Jack and Anne have two adult married children who reside in the greater Charlotte area. Jack is a graduate of Wake Forest University, where he completed his undergraduate degree in accounting. He also graduated from Virginia Tech, where he earned both a Master's and a Doctoral degree in accounting. After graduate school, Jack joined the faculty of the Turner School of Accountancy at the University of North Carolina, where he has been a member of the faculty for the past 36 years.

Jack grew up in a Christian home and committed his life to Christ at Windy Gap (a Young Life Camp) in 1975. Jack was first called and elected to serve as a Ruling Elder at Forest Hill Church in Charlotte, NC. During a time of significant growth, the Forest Hill Session voted to begin church planting. Jack voted in favor of this motion, and, much to his surprise, he found himself in a skating rink in Huntersville, NC, stacking chairs two years later. Being a part of starting and establishing Lake Forest has been a very fulfilling experience. He has served on the active session many times and has been a part of many search committees that hired staff as the church grew.

When the Lake Forest Session felt the time was right to begin their own church planting work, Jack was appointed as a co-leader of the Church Multiplication Commission along with Teaching Elder Mike Moses. To date, Lake Forest has planted five new churches, including Storyhill Church, Lake Forest Westlake, Lake Forest El Buen Samaritano (a Spanish-speaking plant), Lake Forest UCity (a multi-ethnic plant), and Lake Forest Cabarrus.

For the past 11 years Jack has served as a member of the EPC's National Church Planting Team. He has focused on helping the team organize its work and develop a national approach for church planting including the work of the National Director and the Regional Directors. He has also been a part of planning and attending the annual EPC Church Planter's Retreat.

We each, through our various agencies and courts, will seek tangible ways to express our commonality of purpose in witnessing to the gospel of Jesus Christ.

These expressions may include:

- Invitations for appointed representatives of each denomination from time to time, to attend and exchange fraternal greetings at meetings of their General Assemblies.
- Opportunities for ministers in training to benefit from exchange visits and other means of educational cooperation, for the enrichment of their preparation for ordination and service.
- Consultation between office-holders, and practical cooperation where appropriate, on matters of mutual concern in mission and ministry, including (but not limited to) local mission, overseas partnerships, public policy, and the wider mission of the Church of Christ.
- The mutual sharing of published resources and research, sharing models of best practice, and other insights for the enhancement of the life and witness of our churches.
- Possibilities for short-term mission-team visits and other similar ventures to be mutually supported, as appropriate.
- Encouragement of bi-lateral bonds of fellowship between congregations of both denominations, including prayerful and relational support, pulpit exchanges, and visits.

This Committee shall oversee the training of the Candidate, giving encouragement and pastoral attention, and making an annual report to the Presbytery of the progress of the Candidate <u>and, if the Candidate fails to make appropriate progress, recommend termination of candidacy</u>. G. A Candidate shall pursue a course of study that leads to a Master of Divinity degree from an accredited seminary approved by the Presbytery, and such other standards as may be determined by Acts of the General Assembly. - **G.11-2.C** – The Applicant becomes a Candidate under care upon declaration of the Moderator.
- **G.11-2.D** – Since Candidates remain members of the local church during their preparation for ordination, a Liaison between the Candidate and the Session provides fuller care for the Candidate.
- **G.11-2.E** – This provision would give the Presbytery freedom to assign a Candidate's Pastor as the Advisor when deemed appropriate. It also clarifies that the spiritual nurture and oversight of a Candidate lies with the Session and not solely with the Pastor.
- **G.11-2.F** – The supervision of a Candidate may determine that the Candidate has ceased preparation for ordination or is in some other manner failing in the needed preparation for

office. The details for this evaluation are included in the *Procedural Manual for Ministerial Committees* (p. 43).

- **G.11-2.G** – This clarifies that there are two educational pathways toward ordination: a Master of Divinity degree, and education equivalent to a Master of Divinity degree. For a description of “equivalent” see: *Acts of Assembly* 82-07; 12-12; and 14-08.
- Deletion of present **G.11-2.I** – This would eliminate the ambiguous and often confusing third “extraordinary” pathway toward ordination.

Whereas, The EPC Position Paper on Human Sexuality rightly begins by acknowledging “In a time when views of human sexuality and marriage are rapidly changing, we believe it is necessary and helpful to state clearly and compassionately to the church and the world our beliefs about God’s design for human sexuality” and

Whereas, the 37th General Assembly provided helpful guidance to the Church and the world that was both clearly stated and compassionate in its adoption of the Position Paper on Human Sexuality as to God’s design and purposes for sexual unions and

Whereas, the same position paper offers only limited commentary on the institution of marriage and none on the challenge of divorce and

Whereas, the extant EPC Position Paper on Divorce and Remarriage does not achieve the level of clarity and compassion of the EPC Position Paper on Human Sexuality and

Whereas, the extant EPC Position Paper on Divorce and Remarriage fails to address many questions the contemporary reader has regarding a biblical theology of divorce and remarriage therefore

Be it resolved that the 45th General Assembly of the EPC direct the Permanent Committee on Theology to review the current position paper on Divorce and Remarriage; to study the scriptures, the Westminster Confession, the EPC Position Paper on Human Sexuality and other relevant theological works and to revise the EPC Position Paper on Divorce and Remarriage to the end that it clearly and compassionately communicates what we believe the Bible teaches about the matter to a contemporary audience.

Be it further resolved that the committee is directed to address such questions including but not limited to the following:

- What constitutes a true marriage in the eyes of God? (The State identifies some unions as “marriages” that the Church would not accept as such. It is therefore incumbent upon the Church to clarify its teaching as to precisely when a relationship becomes a marriage).
- What biblical guidance is given to the wife or husband who suffers abuse at the hands of their spouse?
- What biblical guidance is given to the wife or husband whose children suffer abuse at the hands of the other spouse?



- What is the definition of abuse, and specifically the form(s) of abuse that may prove to be sufficient grounds for a biblical divorce?
- What is the counsel of the Church in the case where both partners are penitent yet remain unwilling or unable to manifest God's design and purpose for their marriage? (In this question the assembly critiques the assumption in section V of the existing position paper that there exists in all or most cases of marital duress an "offending" and an "offended" party. In reality this dichotomy often proves false).
- What counsel does the Assembly give couples who have experienced the trauma of adultery? The extant position paper directs only that forgiveness be offered. How is the Church to seek to protect, in the case of adultery, the offended party if and when he/she offers forgiveness and reconciliation and how does the Assembly counsel such couples to move toward reconciliation?
- What is the counsel of the Church to persons who are, in the eyes of the state, married in a same-sex union and, potentially, with children?
- What resources does the Assembly recommend for further study, premarital counseling and marriage counseling?

Be it further resolved that the committee shall report its preliminary findings/draft revision to the 46th General Assembly and submit its final draft for consideration by the 47th General Assembly.

45-28 (to the floor)
From Benefits Resources, Inc. Board of Directors

The Benefit Resources, Inc. Board of Directors recommends that the 45th General Assembly **APPROVE** ordained ministers drawing retirement income from the EPC 403(b)(9) Defined Contribution Retirement plan be allowed to designate up to 100% of their retirement income for housing allowance as permitted by applicable regulations, adopted pursuant to the internal revenue code.

Rationale:

To do so permits retired, ordained ministers to take advantage of this significant tax benefit in retirement, thereby making more of their retirement income available for living expenses. Adopting this recommendation on an annual basis provides retired ministers with a readily available reference if asked by tax authorities.

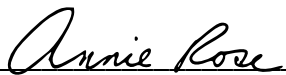

Whereas Robert’s Rules of Order in the 12th edition added consideration for Electronic or Machine Voting (45:42-43) by stating the following: “In many organizations - especially in those comprising hundreds of voters - the process of verifying and counting votes is greatly simplified by the use of electronic or mechanical voting devices, such as handheld keypads or standalone voting machines. The use of such devices to conduct voting may be directed by a special rule of order or convention standing rule or, for a particular vote, by a motion relating to methods of voting and the polls. Their use to fulfill a ballot requirement in the bylaws may be directed in the same manner, provided that the devices meet the criteria for a ballot vote as stated in [RRoO 12th ed.] 45:18. Members must be able to indicate their choices without revealing how they have voted. If the devices are to be used for an election, provision must be made to allow voters to cast write-in votes. If the devices are to be used to conduct voting on several questions or several independent offices simultaneously, then they must be programmed to allow the number of votes cast for purposes of computing the majority to be tallied independently for each question or office (see [RRoO 12th ed.] 45:36). Where such devices are to be used, the following considerations are important:

- Preparations for the meeting should be made in consultation with the person in charge of installing the devices and overseeing their use, so that all adjustments required by the particular conditions of the meeting can be provided for.
- Persons who are to tend the devices during voting must be carefully instructed in their duties, and must be able to explain the use of the devices to voters.
- If there are likely to be many voters who have never used the devices, it may be advisable to have a device available for voters' inspection on a day previous to the meeting or to conduct a practice vote at the start of the meeting.”; and

Overture of the Presbytery of the Midwest (EPC)
to
the 45th General Assembly of the Evangelical Presbyterian Church
on the matter of
A Revision of the EPC Position Paper on Divorce and Remarriage

Whereas, The EPC Position Paper on Human Sexuality rightly begins by acknowledging “In a time when views of human sexuality and marriage are rapidly changing, we believe it is necessary and helpful to state clearly and compassionately to the church and the world our beliefs about God’s design for human sexuality” and

Whereas, the 37th General Assembly provided helpful guidance to the Church and the world that was both clearly stated and compassionate in its adoption of the Position Paper on Human Sexuality as to God’s design and purposes for sexual unions and

Whereas, the same position paper offers only limited commentary on the institution of marriage and none on the challenge of divorce and

Whereas, the extant EPC Position Paper on Divorce and Remarriage does not achieve the level of clarity and compassion of the EPC Position Paper on Human Sexuality and

Whereas, the extant EPC Position Paper on Divorce and Remarriage fails to address many questions the contemporary reader has regarding a biblical theology of divorce and remarriage therefore

Be it resolved that the 45th General Assembly of the EPC direct the Permanent Committee on Theology to review the current position paper on Divorce and Remarriage; to study the scriptures, the Westminster Confession, the EPC Position Paper on Human Sexuality and other relevant theological works and to revise the EPC Position Paper on Divorce and Remarriage to the end that it clearly and compassionately communicates what we believe the Bible teaches about the matter to a contemporary audience.

Be it further resolved that the committee is directed to address such questions including but not limited to the following:

- What constitutes a true marriage in the eyes of God? (The State identifies some unions as “marriages” that the Church would not accept as such. It is therefore incumbent upon the Church to clarify its teaching as to precisely when a relationship becomes a marriage).
- What biblical guidance is given to the wife or husband who suffers abuse at the hands of their spouse?
- What biblical guidance is given to the wife or husband whose children suffer abuse at the hands of the other spouse?



- What is the definition of abuse, and specifically the form(s) of abuse that may prove to be sufficient grounds for a biblical divorce?
- What is the counsel of the Church in the case where both partners are penitent yet remain unwilling or unable to manifest God's design and purpose for their marriage? (In this question the assembly critiques the assumption in section V of the existing position paper that there exists in all or most cases of marital duress an "offending" and an "offended" party. In reality this dichotomy often proves false).
- What counsel does the Assembly give couples who have experienced the trauma of adultery? The extant position paper directs only that forgiveness be offered. How is the Church to seek to protect, in the case of adultery, the offended party if and when he/she offers forgiveness and reconciliation and how does the Assembly counsel such couples to move toward reconciliation?
- What is the counsel of the Church to persons who are, in the eyes of the state, married in a same-sex union and, potentially, with children?
- What resources does the Assembly recommend for further study, premarital counseling and marriage counseling?

Be it further resolved that the committee shall report its preliminary findings/draft revision to the 46th General Assembly and submit its final draft for consideration by the 47th General Assembly.



Overture Concerning Ruling Elders as Candidate Advisors

Summary

The Presbytery of the Midwest overtures the General Assembly to edit the Book of Government 11-2.E. to allow for ruling elders to serve as advisors to candidates under care.

Proposed Change

Current Reading: The Presbytery shall assign **a Teaching Elder** in the Presbytery, ordinarily not the Candidate's Pastor, to serve as advisor to the Candidate. The advisor and the Candidate's Pastor shall submit regular reports to the appropriate committee on the progress of the Candidate.

Proposed Reading: The Presbytery shall assign **a Teaching Elder or a Ruling Elder** in the Presbytery, ordinarily not the Candidate's Pastor, to serve as an advisor to the Candidate. The advisor and the Candidate's Pastor shall submit regular reports to the appropriate committee on the progress of the Candidate.

Rationale

A candidate under care needs two types of supervision, spiritual supervision as they discern a call to ministry and administrative supervision from the presbytery as they seek to navigate the complicated process of ordination. A candidate's pastor (or pastoral designee) is well equipped for the first task, and a candidate's advisor is well positioned for the second. This is in line with the Procedure Manual for Ministerial and Candidate Committees, which describes advisors as "project managers" who connect the candidate to the presbytery.

In the Midwest Presbytery, the candidate care director defaults to this 'project manager' role since the candidate's advisor typically does not serve on the Ministerial Committee. At other times, a ruling elder has been assigned as a 'liaison' to fulfill this role instead, but the Book of Order forbids a ruling elder from serving as the candidate's advisor. In these cases the advisor is a third elder with an unclear responsibility for the candidate.

This change would allow us to simply have two roles for the candidate: their pastor, who provides them career guidance and oversees their discipleship, and their advisor, who serves on the Ministerial Committee and oversees the candidacy process.

The Ministerial Committee is usually much better able to make that assessment based on its required review of the annual reports from each TE in the presbytery.
- b. Changes to item “c” still provide the members of Presbytery with an ability to review any specific Terms of Call if need be.

Crossworld has been sending workers for 90 years and has an extensive network of marketplace opportunities that help people of all kinds of vocations find their place in gospel-sharing, disciple-making, and church-planting, utilizing a professional platform.

The Fraternal Relations Committee recommends that the 45th General Assembly **WITHDRAW** its formal fraternal relationship with the Church of Jesus Christ in Madagascar; and that future relationship be through the World Reformed Fellowship.

Rationale:

The Permanent Committee on Fraternal Relations evaluated the relationship between the Evangelical Presbyterian Church and The Church of Jesus Christ of Madagascar and found no evidence that the relationship, as defined in *Acts of the Assembly* 16-07 was in practice. Numerous attempts to contact representatives of the Church of Jesus Christ of Madagascar were unsuccessful. As a result, the committee does not believe this relationship meets the criteria for Fraternal Relations established in *Acts of the Assembly* 12-10. However, relations may still be maintained through the World Reformed Fellowship.
