

# Preventive Care Covered with No Cost Sharing

Checkups, screenings, vaccines, prenatal care, contraceptives and more with no out-of-pocket costs

# Good news! Your health benefits cover the services listed here with no cost to you as part of your preventive care.

# This includes routine screenings and checkups. It also includes counseling to prevent illness, disease or other health problems.

Many of these services are covered as part of physical exams, including regular checkups, and routine gynecological and well-child exams.

You won't have to pay out-of-pocket for these preventive visits when you visit a doctor in your provider network. But these services are generally not preventive if you get them as part of a visit to diagnose, monitor or treat an illness or injury. Then copays, coinsurance and deductibles may apply.

Meritain Health® follows preventive recommendations as determined by the U.S. Preventive Services Task Force, Centers for Disease Control and Prevention and other advisory committees. Screenings, services and other covered preventive services can vary by age, gender and other factors. Be sure to talk with your doctor about which services are right for you

#### Preventive care for adults

## Covered preventive services for adults generally include the following:

#### **Medications and supplements**

Doses, recommended ages, and recommended populations vary.

- Aspirin for women at risk of preeclampsia and adults ages 50–69 with certain heart risk factors\*
- Bowel preparation medication (for preventive colorectal cancer screening)
- Low-dosage statins: dependent on cardiovascular disease (CVD) and risk factors
- Tobacco-cessation medicine approved by the U.S. Food and Drug Administration (FDA), including over-the- counter medicine when prescribed by a health care provider and filled at a participating pharmacy
- HIV pre-exposure prophylaxis (PrEP) medication for members at higher risk
  - Truvada (until a generic version is available)
  - Descovy—covered for members with renal comorbidities or bone disease

#### **Screenings**

- Abdominal aortic aneurysm (one-time screening for men of specified ages who have ever smoked)
- Alcohol misuse
- High blood pressure
- Cholesterol (for adults of certain ages or at high risk)
- Colorectal cancer\*
- Depression
- Diabetes
- Human immunodeficiency virus (HIV)
- Hepatitis B and C
- Lung cancer\* (with history of smoking)
- Prostate cancer\*
- Obesity
- Syphilis (for pregnant women and members at higher risk)
- Tuberculosis (TB) testing
- Tobacco use
- Home blood pressure monitor (one monitoring device per member age 18 and over)

#### Counseling services



- O Alcohol misuse
- O Domestic violence
- O Nutrition (for adults with cardiovascular and diet-related chronic disease)
- O Obesity
- Sexually transmitted infection (STI) prevention (for adults at higher risk)
- O Tobacco use (including programs to help you stop using tobacco)

#### **Immunizations**

Doses, recommended ages, and recommended populations vary.

- Tetanus, diphtheria, pertussis (Tdap)
- Hepatitis A and B
- Herpes zoster
- Human papillomavirus (HPV)
- o Influenza (flu)
- Measles, mumps, rubella (MMR)
- Meningococcal (meningitis)
- Pneumococcal (pneumonia)
- Varicella (chicken pox)

#### Preventive care for women

### Covered preventive services for women include the following:

#### Screenings and counseling services

- Breast cancer chemoprevention if you're at a higher risk
- Breast cancer (BRCA) gene counseling and genetic testing for members at a higher risk in place of this
- Breast cancer mammography
- Cervical cancer\*
- Chlamydia infection\*
- Gonorrhea
- Interpersonal or domestic violence
- Osteoporosis\* (depending on risk factors)

#### **Medications and supplements**

- Folic acid supplements (for women of child-bearing ages)
- Risk-reducing medicine, such as tamoxifen and raloxifene, for women with an increased risk for breast cancer\*

#### Counseling and services\*\*

- Prescribed FDA-approved female over-the-counter or generic contraceptives<sup>2</sup> when filled at an in-network pharmacy
- Two visits a year for patient education and counseling on contraceptives
- Voluntary sterilization services

#### Preventive care for pregnant women

### Covered preventive services for pregnant women

- Routine prenatal visits (you pay your normal cost share for delivery, postpartum care, ultrasounds or other maternity procedures, specialist visits and certain lab tests)
- Anemia screenings
- Diabetes screenings
- O Bacteriuria urinary tract or other infection screenings
- Rh incompatibility screening, with follow-up testing for women at higher risk
- Hepatitis B counseling (at the first prenatal visit)
- Expanded counseling on tobacco use
- Maternal depression screening and counseling
- Breastfeeding interventions to support and promote breastfeeding after delivery, including up to six visits with a lactation consultant\*

# Covered preventive supplies for pregnant women



- Breast pump supplies (one set per birth)
- Certain standard electric breastfeeding pumps (nonhospital grade) anytime during pregnancy or while you are breastfeeding (one per birth)
- Manual breast pump anytime during pregnancy or after delivery for the duration of breastfeeding

## Covered preventive services for children include the following:

#### Screenings and assessments\*

- Adolescent depression screening
- Alcohol and drug use
- Anemia
- Attention deficit disorder (ADD)
- Autism
- Behavioral and psychological issues
- Congenital hypothyroidism
- Development
- Hearing
- Height, weight and body mass index
- Hematocrit or hemoglobin
- Hemoglobinopathies or sickle cell
- Hepatitis B
- O HIV
- Lead (for children at risk for exposure)
- Lipid disorders (dyslipidemia screening for children at higher risk)
- Medical history
- Newborn blood screenings
- Obesity
- Oral health (risk assessment)
- STIs
- TB testing
- Vision

#### **Counseling services**

- Obesity
- Sexually transmitted infection (STI) prevention (for adolescents at higher risk)

#### **Medications and supplements**

- Gonorrhea preventive medication for the eyes of all newborns
- Oral fluoride for children\* (prescription supplements for children without fluoride in their water source)
- Topical application of fluoride varnish by primary care providers

#### **Immunizations**

From birth to age 18—doses, recommended ages and recommended populations vary.

- Tdap/diphtheria, tetanus, pertussis (DTaP)
- Haemophilus influenzae type b
- Hepatitis A and B
- Human papillomavirus
- Inactivated poliovirus
- Influenza
- Measles, mumps, rubella (MMR)
- Meningococcal (meningitis)
- Pneumococcal (pneumonia)
- Rotavirus
- Varicella (chicken pox)
