### 403(B)(9) ACCOUNT DISTRIBUTIONS

As a participant in our 403(b)(9) retirement account, you may be eligible to take a distribution. Check out our distribution form **here** for more detail on the different reasons you may be eligible. In order to take a distribution, you may call Fidelity at 800-343-0860 and initiate transaction by phone or you may fill out the distribution form on our website found **here**.

On all our forms, you will see a Plan Sponsor section — that's us! A member on our team must sign off on any distribution request before it is submitted to Fidelity. Forms can be faxed, emailed, or mailed to our office for signature. After we approve your request, we submit directly to Fidelity for processing.

#### **Did You Know?**

A unique feature of a 403(b)(9) is that ordained ministers may allocate a portion of their retirement withdrawals to tax-exempt housing allowance, subject to IRS limits. Once retired or no longer active under our 403(b)(9), please indicate to Fidelity you are eligible for the EPC minister housing allowance when requesting your withdrawal. If

you transfer your funds to a separate account, please verify the plan rules as this benefit may no longer be available. Log in or **register** your account through **www.netbenefits.com/EPC**.
