HSA News! Each year, the IRS gives you the chance to contribute up to a certain amount to your HSA. To get the most out of this savings opportunity, you should consider contributing the maximum allowed:

HSA ANNUAL CONTRIBUTIONS LIMITS		
Tax Year	Individual Coverage Limit	Family Coverage Limit
2020	\$3,550	\$7,100
2021	\$3,600	\$7,200
At age 55, members can contribute an additional \$1,000 beyond IRS limits.		

*If you and your church are both contributing make sure not to go over the limit!

COVID-19 VACCINATIONS

Great news that so many now have the opportunity to be vaccinated!

If you are in the EPC medical plan there is no cost to you regardless of where you go to have it administered. If you are still scheduling yours, check with your state or local government authorities for the nearest locations.

Keep in mind that by scheduling at a local government sponsored site you will save your health plan the cost of the vaccine and its administration.
