## **Changes to Your Benefits Reminder**

There are only **3 times** you can make changes to your benefits...

- 1. When you first get hired
- 2. During open enrollment (Month of November each year)
- 3. When you have a Qualifying Life Event

#### Common events are:

- Change in employment status
- Marriage
- Divorce
- Death
- Addition of a child through birth or adoption (the need to add coverage for them can be easily overlooked so remember to add them right away)

\*When a dependent child turns age 26, coverage will be terminated at the **end of their birth month.**
