We commit to review the terms of this authorization annually and adjust it appropriately (considering all applicable factors, including changes in cost of living). We commit to paying expenses related to your move to the field up to \$ \_\_\_\_\_

In order that you may fulfill the responsibilities assigned to you by virtue of this call, we also grant you the special powers as designated below and prescribed in the EPC *Book of Government* 9-5C.

- To share the gospel
- To administer the sacraments
- To develop a church
- To conduct preparational meeting of such church
- To oversee the required preparation of Elders and Deacons
- To receive and dismiss members
