General Description:

The Marriage Ministry Director is a key member of the Senior Shepherd leadership team responsible for cultivating healthy and vibrant Christ-centered marriages for every age and stage (pre-marital, newly married, seasoned to empty-nesters), leading and shepherd staff for College, Young Adults, Middle Adults (Collective), Men, and Senior Adults.

Essential Duties and Responsibilities:

- Build, lead and grow the impact of Marriage Ministry throughout all life stages at Hope.
- Lead the relengage program as a front door to marriage enrichment and group formation.
- Create relevant events, Bible studies, retreats and seminars regarding practical issues of life that will
 enhance the spiritual and relational growth of dating and married couples.
- · Prepare and manage ministry budget.
- Build and coach a team of mentors to help shepherd and facilitate the core programs: re|engage (marriage enrichment) Rules of Engagement (pre-marriage) and Refresh (marriage conference)
