## The Types of Questions You Will Be Asked\*

\*Note: these are only examples of the type and scope of questions that will be asked.

# **General Theology examples:**

- 1. Define perichoresis and explain its significance.
- 2. What is the doctrine of the hypostatic union?
- 3. What is the kenosis passage and what is its meaning?
- 4. What does it mean for Jesus to be the firstborn?
- 5. Is salvation by faith or by works or both? Provide scriptural support for your answer.

#### <u>Reformed Theology examples:</u>

- 1. What is meant by sola Scriptura? Why does the Confession of Faith insist that neither new revelations of the Spirit or traditions of men should ever be added to the Scriptures?
- 2. Defend the deity of each person of the Trinity, with Scriptural proof.
- 3. According to the Westminster Confession of Faith, who is the supreme judge of all religious councils? (WCF 1.10)
- 4. According to the Westminster Confession of Faith, how do God's omniscience and
- 5. foreknowledge relate and differ? (WCF 3.2)
- 6. Describe the interworking of "first cause" and "secondary causes." (WCF 5.2)
- 7. Define the Five Solas and state what they spoke against.
- 8. Is the "rapture" a biblical doctrine? Explain.
